

IMMIGRATION LAW ALERT* *VISA LOTTERY

Dear Client or Colleague:

We are delighted to inform you that the DV Immigration Visa Lottery for 2024-2025 has begun. This Lottery provides 50,000 permanent residence visas (“green cards”) for everyone, except **the following countries are excluded: Bangladesh, Brazil, Canada, China (Hong Kong SAR), Colombia, Dominican Republic, El Salvador, Haiti, Honduras, India, Jamaica, Mexico, Nigeria, Pakistan, Philippines, South Korea, United Kingdom (except Northern Ireland), Venezuela and Vietnam.** All other countries are eligible, including Macau SAR, and Taiwan.

If your parents or spouse were born in a country not excluded, then you have **“Derivative Status”**, and you can still apply. Your spouse can also include you in their separate application. Children under 21 years old are included in your application. The Lottery is available to every person over 18 years old. Since the Lottery Visa Program started in 1991, our clients through our office won more than 205 Lottery Visas (green cards) for our clients.

Your application must be filed prior to the deadline of Wednesday, November 1, 2023. You must file within the strict deadline. If you or someone you know wishes to participate in this visa lottery, please contact our office as soon as possible to provide us with the information needed on the Visa Lottery Application. Please provide us with your I.D. Page of a Valid Passport and a NEW passport style photograph, acceptable ONLY on JPEG format, (1 inch X 1-3/8 inches) with a maximum image file size of 240 kilobytes (240 KB), with an image resolution of 600 pixels high by 600 pixels wide and with an image in color (24-bits per pixel). Please include your payment in the amount of \$350 for one and \$500 for two; checks or wires must be made payable to “FINLEY & BOLOGNA INTERNATIONAL. Please call our offices in Miami (305-379-7676) or Wellington (561-478-9930) if you have any questions regarding this application. **Immigration will only accept one application per person.** This application is separate and apart from any other type of visa application, and will not adversely affect or prejudice any application that may have already been filed with Immigration or the U.S. Embassy abroad.
